At least 6 credits must be upper- level courses as defined by the College of Food, Agricultural, and Environmental Sciences (3000 level or above).
The minor in Turfgrass Management is for students who expect to have positions that require (a) overseeing the management of grounds (for example public or private lawns, sports, or recreational areas, or (b) golf courses (greens and fairways). The Turfgrass Management minor consists of 14 hours selected as follows (at least 6 credits must be taken at the 3000 level or higher):	 <u>Transfer and EM credit hours allowed</u> A student is permitted to count up to 6 total hours of transfer credit and/or credit by examination. <u>Overlap with the GE</u> A student is permitted to overlap up to 6 credit hours between the GE and the minor. <u>Overlap with the major and additional minor(s)</u> The minor must be in a different subject than the major. The minor must contain a minimum of 12 hours distinct from the major and/or additional minor(s).
