The objectives of a minor in Entomology are to provide insight into the role of insects in human affairs and in the environment. Students majoring in fields associated with natural resource management, sustainable agriculture, food production, ecology, and agriscience education will be interested in Entomology because of the critical role insects play in natural and managed ecosystems. Students majoring in fields associated with animal sciences, pre-veterinary medicine, and public health will be interested in Entomology because of the critical role insects play in animal and human health.

**The Entomology minor consists of a minimum of 12 credit hours chosen from the following list.**

**Required:**

**Required course in applied entomology, select one course from the following:**

**This minor is not available to students majoring in Plant Health Management or Entomology.**

**Entomology minor program guidelines**

Credit hours required A minimum of 12 credit hrs . 1000 level courses shall not be counted toward the 12 credit hr minimum. At least 6 credits must be at the 3000 level or above.

Transfer and EM credit hours allowed A student is permitted to count up to 6 total hours of transfer credit and/or credit by examination.

Overlap with the GE A student is permitted to overlap up to 6 credit hours between the GE and the minor.

Overlap with the major and additional minor(s)

- The minor must be in a different subject than the major.
- The minor must contain a minimum of 12 hours distinct from the major and/or additional minor(s).

Grades required

- Minimum C- for a course to be listed on the minor.
- Minimum 2.00 cumulative GPA for all minor course work.
- Course work graded Pass/Non-Pass cannot count in the minor.
- No more than 3 credit hours of coursework graded Satisfactory/Unsatisfactory may count toward the minor.

X193 credits No more than 3 credit hours.

Minor approval Not required as long as students complete the courses as indicated on the minor program description.

Filing the minor program form The minor program form must be filed at least by the time the graduation application is submitted to a college/school advisor.

Changing the minor Once the minor program is filed in the college office, any changes must be approved by filing a petition for change in the minor through the academic unit offering the minor.
