Note regarding classes taught in English (*): Students electing to take courses taught in English to fulfill the certificate program must demonstrate proficiency at the Intermediate High level prior to enrollment in CLLC 5103. Proficiency may be established by taking two 4000-level courses taught in the working language or through approved proficiency testing in the working language (OPIc, Versant, STAMP).

Translation and Interpretation Certificate program guidelines:

Credit hours required: Minimum of 12 credits.

Overlap with courses in a degree

- The certificate must be in a different subject than the major.
- Max 50% overlap with courses in a major, minor, other certificate, or GE

Grades required

- Minimum C- for a course to be listed on the certificate.
- Minimum 2.00 cumulative point-hour ratio required for the certificate.

X193 credits: Not permitted.

Declaring the certificate

In order to declare the certificate, students must meet with the Emily Carpenter prior to the filing of the certificate completion paperwork and/or graduation application. Please email carpenter.438@osu.edu to make an appointment.

Approval of coursework
